Since then, it has come to be applied by various scholars in diverse fields of endeavours. Crossman writes: "Over the years, rational choice theorists have become increasingly mathematical. Even Marxists have come to see rational choice theory as the basis of a Marxist theory of class and exploitation" (p. 1).

Moss (2016) also lends his voice in support of the wide applicability of the rational choice theory.
