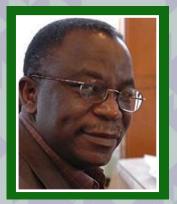

The meaning, scope, and implications of ethnicity and tribe are the subjects of scholarly debates. In the African experience, they are sometimes interchanged with words like "race" and "nation," and used to refer to a group identity based on one or several of the following indices: a common history, culture, language, and so on. Despite their loose applications in everyday contexts, scholars try to maintain the distinctions between these slippery concepts, showing their evolution and scope. For instance, "while one formerly spoke of 'tribes', the term 'ethnic group' is nowadays much more common" and ethnicity seems "a wider concept" (Eriksen, 2010). Because these two concepts are ambiguous, we welcome critical attempts to understand them better in relation to African peculiarities.

Whatever the case, ethnic and tribal identities appear to be subjects of constant (re)negotiations informed by various motivations. Colonial and political factors transformed ethnic and identarian relations amongst African peoples in many ways: close "tribal" groups bonding under one ethnic identity or declaring themselves distinct from the rest, or new colonial/political boundaries separating

ethnic kins from each other. Again, with the new socio-economic structures introduced via colonialism, "the localized, broad-based, low-risk, self-sustaining subsistence activities [of African groups] gave way to high-risk, stratifying competition for state power and scarce resources, a zero-sum conflict of identities based on tribalism or ethnicity" (Deng, 1997). After colonialism, the efforts of African states to maintain inherited colonial boundaries have exacerbated ethnic conflict and tribal animosities, rendering the so-called unity in these countries fragile and precarious. From the Nigerian Civil War of 1967-70, the Rwanda genocide of 1994, the Darfur crises in Sudan, and some recent crises in Africa, "the primary fault line of confrontation is one of ethnic distinctions" (Cordell and Wolff, 2010). However, despite these ethnically inflected dark events in African history, 21st-century Africa is still challenged by ethnicism and tribalism. 21stcentury political rhetoric in Africa shows that "ethnicity is clearly a resource for political manipulation and entrepreneurship" (Deng, 1997), and desperate politicians milk it for selfish reasons. Because of people's passionate connection to their tribe or ethnicity, appeal to either is a powerful way of mobilizing groups for various reasons and setting up a we-versus-them binary that resultantly chafes the threads of national cohesion. For instance, a country like Nigeria is still suffering from the ethnic and tribal rhetoric/violence that dotted its 2023 presidential elections.

Because of their immanence in 21st-century conversations around social cohesion in African states, an all-level interrogation of the concepts in relation to African realities is necessary at this time. We invite scholars to reflect on tribe and ethnicity in Africa from their peculiar disciplinary lenses, positionalities, and methodologies. What is the texture of tribe and ethnicity in Africa today? Should African countries deemphasize tribe and ethnicity in socio-political organizations? How can we repurpose the galvanizing power of tribal appeal and ethnic loyalty to serve useful national objectives? For instance, Gloria Anzaldua proposes the term "new tribalism" which means a "social identity that could motivate subordinated communities to work together in coalition" (2012). Are there examples of these new tribalisms in Africa? What challenges have confronted them? Are there instances of the inversion of new tribalism's goal, like oppressive groups forming a coalition to keep subordinated communities repressed and oppressed? What can the fields of sociology, anthropology, archeology, mass/new media, languages, philosophy, education, performing arts/representational discourses, etc teach us about Africa's experience with ethnicity and tribe? How can their engagements with these concepts "help create tolerance and understanding between citizens, thereby leading to social cohesion" (Holm, Jarrick, and Scott, 2015)? questions are not limited to the above, and so we invite scholars and stakeholders to submit abstracts that fall within the subthemes below or the overarching theme above.
