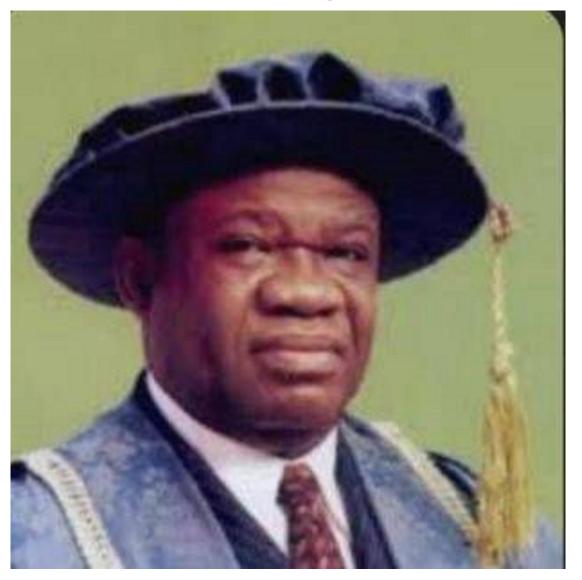

# Awardees & Citations



VERY REV. PROFESSOR CHINEDU OSITADINMA NEBO, CON, NPOM, OON, FNSE, FNMS, FMSN, FNIPE, FNATE, FNAEng, FNMMM

Professor Chinedu Nebo was born in Kafanchan to the family of Mr. & Mrs. Christopher O. Nebo on 3rd June, 1952. He had his primary school education in Ibadan, Kafanchan and Port Harcourt where he bagged the First School Leaving Certificate with Distinction. Professor Nebo then proceeded to attend Government Secondary School Afikpo, where he passed his School Certificate Examination with flying colours. Chinedu, thereafter won a Federal Government Scholarship to study Mining Engineering in South Dakota School of Mines and Technology USA, known then as a top institution for Minerals Engineering studies.

Professor Nebo graduated with First Class Honours in Mining Engineering and at the top of his graduating class. He also bagged a Master of Science degree in Metallurgical Engineering and a Ph.D. in Materials Engineering & Science. An accomplished engineering scholar, Professor Nebo served the



then Anambra State University of Technology which metamorphosed into Enugu State University of Science & Technology (ESUT) and Nnamdi Azikwe University at the creation of Enugu State. Prof. Nebo rose in rank to become a Professor of Metallurgical and Materials Engineering. He served as Dean of Student Affairs for several years before being appointed in January 2000 as the sole Deputy Vice Chancellor of ESUT. At the completion of his tenure as Deputy Vice Chancellor, he contested for and was appointed Vice Chancellor of the University of Nigeria, Nsukka (UNN).

A seasoned, humble and astute administrator, Prof. Nebo rebuilt UNN, completing most of the abandoned projects and started and completed scores of other projects, including building a Lecture Hall for every Faculty in the University from IGR only, and without any assistance from government. An ordained servant of God, Prof. Nebo restored peace and harmony in a University that was referred to as "National War College II" in some circles. During his tenure, UNN did not take part in any strikes. At the end of his tenure as Vice Chancellor of UNN, Prof. Nebo was again invited to serve as the pioneer Vice Chancellor of Federal University, Oye-Ekiti, where he performed the feat that was dubbed "the Six Month Miracle", by converting a virgin forest to a university campus within six to eight months and starting lectures on the permanent site before any of the other new universities. He equipped the University with such modern Information Communication Technology (ICT) facilities that resulted in the new university being recently ranked webometrically as number 17 in Nigeria, way ahead of most Federal and State universities. It was in the process of building a modern, brand new University from the scratch that President Goodluck Ebele Jonathan, GCFR, appointed Prof. Nebo as Minister of Power of the Federal Republic of Nigeria.

As Minister of Power, Prof. Nebo, provided strong dependable and proactive leadership for a problematic sector that was in a period of transition. He enrolled the cooperation of the Unions which made for a seamless transition from a government-owned and controlled electricity industry to a private-owned and driven industry; an exercise that is described outside Nigeria as the largest and most elaborate privatization of utilities globally.

Prof. Nebo has brought about unprecedented synergy and cooperation within the energy sector, championing engagement of all players in a bid to solve Nigeria's power problems. He midwifed Operation Light Up Rural Nigeria and the popular maxim in the Federal Ministry of Power is "No Nigerian or community left in darkness".

Prof. Nebo continued to serve within the Church as an ordained minister, rising to the position of Provost of the Diocesan Cathedral Church, before retiring at age 70. In July 2023, Prof. Nebo was appointed the pioneer Vice Chancellor of University on the Niger, Umunya, becoming the first person in the history of NIgeria to serve as Vice Chancellor three times in a lifetime (two Federal Universities and one Private University). He is also currently the Pro Chancellor and Chairman of Council for Coal City University.

Prof Nebo is married to his heartthrob Ify, and they are blessed with four children and twelve grand-children.

Nkadi Onyegegbu is at present, Professor in the Science Education and a Reproductive Health and Sexuality Educator in Science Education Department of University of Nigeria, Nsukka. She is the current Director, Gender and Development Policy Center, a past Head of Department, Science Education and past Director, Institute of Education. She holds a BSc. in Microbiology, a PGDE in Science Education, M.Ed and Ph.D. in Science Education. Her academic career is garnished with strings of academic publications. She has edited ten books, contributed chapters in many books and has published avalanche of academic articles in renowned national and international journals. She was the Editor-in-Chief of Review of Educational Journal, African Journal of Science, Technology and Mathematics Education (AJSTME) and Editor of Educational Research Journal and Online African Journal of Education. She has also for over fifteen

years successfully organized and co-coordinated International, National researches, and seminars, workshops, conferences for institute of Education and Leadership Training programs for the University of Nigeria, Nsukka. Her professional activities can be measured by her membership in ten professional societies and associations. She is a Fellow of Science Teachers Association of Nigeria (STAN) and a member of National Academy of Education (NAE). She is also a Director in Global Health Awareness Research Foundation (GHARF), Lift Saxum, SpeakUP Africa and Women Leadership Institute International (WLI).

**As a Teacher**, Professor Nkadi Onyegegbu, has supervised nine Ph. D students and fifteen MED and twenty two undergraduate projects in Science Education. #### **EARLY LIFE AND EDUCATION**

HRM, Igwe Samuel Ikechukwu Asadu Jnr was born to the family of late Sir and Lolo Asadu Samuel Ejikeme of Ozalla Edem-Ani in Nsukka LGA of Enugu State.

He is the first child in a family of six children. He attended primary school at Central School Edem-Ani and Boys High School, Okpo, Enugu-Ezike. He studied Nursing at School of Nursing, Iyienu, Ogidi, Anambra State. He was employed with the then Anambra State Ministry of Health before traveling to the United State of America where he obtained Bsn at Grand Canyon university in Arizona USA.

#### COMMUNITY/HUMANITARIAN SERVICES

He built and equipped an ultramodern, free twenty-bed hospital for the community, and pays monthly bill of over one million naira to doctors and other staff from 2019 till date.

He recently constructed 2.1 kilometers asphalt road leading from Odenigbo Nsukka to Edem-ani, sponsored erosion control at Ugwu Aji and has donated up to N27,000,000 for reticulation of water in Edem ani.

He has built eight houses for the widows and the indigents from Edem ani community.

He donated 63 million Naira to Edem ani youth on January 2nd 2024.

He also sponsored 24 persons from Akpa, Ozzi, Edem ani and Ugwunagbo to Abuja to seek for greener pastures. In the area of security, he spent millions of Naira in procuring a Hilux Van, motorcycles, Walkie Talkie and other security gadgets to equip the Edem-Ani Neighborhood Watch to secure the community. He recently sponsored solar lights in the whole of Edem ani and Ugwnagbo Community to the tune of N12,000,000. He recently donated a sienna bus to the youth wing of Edem ani Ogwugwu ancient kingdom. In education and youth empowerment, he purchased Jamb forms for about 300 youths of Edem origin. He donated laptops and generators to four primary schools in Edem-ani; donated N5,000,000 to some Edem-Ani youths to start businesses; awarded scholarships to indigent University students; sponsored up to eight of Edem ani indigenes for Masters degree programs abroad with a promise to pay for Masters degree program abroad for any Edem ani indigene who made first class or second class upper in any Nigeria university.

He has sponsored 10 years of the Ogadagidi Children's Party: a platform he uses to reward outstanding students from public primary schools in Edem-ani. Constructed the culverts that links Otobo Ubogidi, Obinagu Ubogidi and Ozalla Umuneje village. Built a food bank that feeds up to 250 people on daily bases since 2022. As a result of these, his community a unanimously agreed to erect his status at the central place in the community which will be there in perpetuity. Igwe Ogadagidi's philanthropic deeds cannot be enumerated in this write up. He is happily married to HRM, Happiness Ederechukwu Asadu (Lolo Akudo) and the marriage is blessed with four wonderful children.

Hamzy! is also the Founder of Follow The Money, a home-grown Pan-African grassroots data-driven initiative currently in 10 African countries and one of the fasted growing movement engaging citizens and leads a team of technology & innovation driven campaigners to amplify voices of marginalized communities in promoting accountability as it affects utilization of public funds focusing on specific communities across Africa. He is currently the Chief Executive of Connected Development (CODE), an organization he founded and under his leadership, CODE won the ONE Africa 2016 Award which recognizes, rewards, and advances the exceptional work of Africa based organizations; dedicated to helping the continent achieve the Sustainable

Development Goals (SDGs).

Hamzy! seats on the Executive Board of the largest Youth Movement in Africa: <u>African Youth Initiative on Climate Change (AYICC)</u>, advising on communications strategies and campaigns using technology tools in shaping and actualizing the Sustainable Development Goals (SDGs) and has joined his voice on different platforms and policy influencing coalitions across Africa such as the <u>Not Too Young To Run</u> movement which drives youth political inclusion.

# Ms. Nwadi Elobuike, THE DIRECTOR TRAINING, NIGERIAN TELEVISION AUTHORITY (NTA) HEADQUARTERS, ABUJA

It was the Czech - born British playwright, Tom Stoppard, who once said, and I quote, "I still believe that if your aim is to change the world, journalism is a more immediate short term weapon." Nwadi Elobuike, a nationally celebrated Broadcaster, has through her love, zeal and commitment to the



distinguished pen profession, been able to navigate to the top of her career, leaving in her trail, some indelible footprints for the young ones to follow. From her years of impactful transformational reportage on Africa's largest Television Network, the NTA to the pinnacle of her excellent career as a Director, Nwadi established herself as a go-getter and jinx breaker. In the course of a three decade running broadcast career, she rose from a News Reporter cum Editor, Presenter to become a Manager, General Manager of Stations and Zonal Director. Until her very recent and current posting to NTA Headquarters, Abuja as the Director of Training, Nwadi Elobuike was Zonal Director, NTA Enugu Network Centre which she was able to reposition as a true Station for Excellence by attracting

the Enugu State Government's solar power project within one year of her service tenure.

The amiable, calm and discrete iconic Broadcaster, Nwadi Elobuike who hails from Eke in Udi LGA of Enugu State was born in the early 1970s. She attended the prestigious Queen's School Enugu, the Enugu State University of Science and Technology where she obtained a double B.Sc. in Mass Communication and Psychology and later, M.Sc. Industrial Psychology.

Nwadi is a selfless compassionate humanitarian with uncommon wisdom and faith. She has since 1998, been championing media and legislative campaigns against obnoxious gender-based traditional practices. In her quest to achieve social justice for the indigent and vulnerable, she founded the Women and Orphans Rights to Family Assets Foundation - WORFAF to provide legal and other assistance to oppressed persons.

May I now present to you, a dedicated, most unassuming, ever cheerful, accomplished Broadcaster and human rights activist, Nwadi Elobuike.





### **Comrade Harrison Gwamnishu**

#### Nigerian Human Rights Activist, Social Entrepreneur and

Harrison Gwamnishu (born 17 July 1989), is a Nigerian human rights activist, social entrepreneur, and philanthropist. Gwamnishu is known for raising awareness about social justice issues, wrongful incarceration, legal reforms, and the well-being of prisoners.

Gwamnishu rose to prominence for his advocacy work on behalf of prisoners, particularly those who have been unjustly incarcerated. Through his organization Behind Bar Human Rights Foundation he has worked to highlight the harsh conditions faced by prisoners in Nigerian jails and to provide



assistance in securing justice for individuals who have been wrongfully imprisoned. His work extends to raising awareness about human rights violations, and advocating for systemic reforms within Nigeria's legal and prison systems. Among his significant contributions is his involvement in the case of Ada Jesus and the high-profile missing person cases of Celine Ndudim and Afiba Tandoh.

Harrison Gwamnishu entered politics as a candidate for the Labour Party during the 2023 Delta State House of Assembly elections, representing the Aniocha South Constituency. Although he lost this election, his participation marked his initial foray into public office. Afterward, he pulled out, announcing his resignation from the Labour Party, citing persistent allegations that he betrayed the party during the campaign. He expressed regret in a social media statement but noted that staying with the party could harm his reputation. He reaffirmed his commitment to the "Obidient Movement," inspired by Peter Obi. Gwamnishu thanked the party leadership for their support and pledged to cooperate with investigations to clear his name.

In August 2024, Gwamnishu was appointed Senior Special Assistant on Civil Society and Youth Mobilization to the Delta State Governor, Sheriff Oborevwori.

The contextual nature of language enables users to employ it directly or indirectly. In a social context, language could be used directly when users sense a seeming correspondence between what is said and what is meant, without creating any form of ambiguities or complexities. On the other hand, when used indrirectly, it breaks the conventional denotative interpretation giving way for meaning to be inferred indrirectly. Breast cancer remains a serious public health concern, and effective treatment and survival are greatly hampered by late detection, which is mostly brought on by an adverse attitude toward the disease. The study investigated the factors determining women's attitudes about breast cancer examination in Nsukka Local Government Area, Enugu state. A multistage sampling procedure was used, and a sample of 204 young and older persons were given questionnaires as part of a cross-sectional survey design. An In-Depth Interview (IDI) was also used to collect qualitative data from the urban and rural groups under study. Version 22 of the Statistical Package for the Social Sciences (SPSS) was used for analyzing the quantitative data, and the qualitative data was used to supplement the quantitative data through thematic analysis. The hypotheses were tested at the 0.05 level of significance using chisquare, a statistical method for analysis. According to the results, only 13% of respondents frequently get breast cancer exams, while a large percentage (76.5%) had never had any form of breast cancer examination. This study investigates ethnic stereotyping in Nigerian political speeches, media interviews, and debates using Van Dijk's Socio-Cognitive Approach to Critical Discourse Analysis (CDA). The data comprises 50,000 words drawn from selected political speeches of President Muhammadu Buhari's 2015 inaugural speech, Goodluck Jonathan's 2015 concession speech, and Atiku Abubakar's 2019 campaign speech and interviews from Channels TV as well as transcripts from the 2023 presidential debates featuring Peter Obi and Rabiu Kwankwaso. These provide insights into the rhetorical framing of ethnicity in political discourse. Findings reveal that politicians use lexical choices, rhetorical devices, and implicit presuppositions to construct in-group and out-group distinctions that reinforce ethnic loyalty. While some political figures advocate national unity, others perpetuate stereotypes that contribute to political exclusion and ethnic tension. This research emphasizes the role of language in shaping ethnic perceptions and calls for more responsible political rhetoric to enhance national cohesion.
